#### 7. The pre-qualification requirement is as under:

#### **Evaluation Criteria:**

#### i) Financial Criteria:

- An average annual turnover of last seven financial years should not be less than the 50 % of tender amount.
- Working capital should not be less than 25 % of Tender Amount. A Bank certificate to be submitted (Certificate from co-operative bank will not be accepted).
- solvency should not be less than 2 Lacs from any Nationalized bank or scheduled bank (Certificate from co-operative bank will not be accepted)

#### ii) Experience Criteria:

- The bidder should have an experience of satisfactory completion of work of similar nature & magnitude in last seven years as <u>main contractor in</u> <u>Any Government or Semi government Organization.</u>
- One work of similar nature of 60 % of Tender Amount. **Or**
- Two works of similar nature of 50 % of Tender Amount.
- The bidder should have required nos. of expertise and sub-ordinate staff.
- Bidder shall have registration in <u>Class-'E-1' and above</u> with State or Central Government, Semi-Government in appropriate class and shall also have electrical contractor license.

#### iii) Availability of tools, plant, & manpower.

- The agency should have adequate number of tools, plant along with required experienced staff for carrying out this work. (Details of staff & tools with agency must be submitted in tech bid physically duly certified.)
- Joint venture is not permitted for this work.

- 1. Providing skilled, Semiskilled & Unskilled workers as per tender for running of water pump house, filter plant and swimming pool whenever required.
- 2. Cleaning the complete site every day as per instruction by in charge.
- 3. Operation of all control valve of water pump house, filter plant and swimming pool.
- 4. Maintain Logbook, attendance register, preventive maintenance work register etc if required
- 5. alum/PAC dozing should be done as per instruction by chemist.
- 6. Filter bed back washing, recycling valve operation of backwash water.
- 7. pre and post chlorination.
- 8. regular cleaning penal, machinery, sludge/algae, grass and bruises and unwanted trees and plants as and when required and instructed should be done.
- 9. Operation of all suction delivery valve of pump, control valve of filter water sump bypass and plant / gate valve, supply valve etc.
