The e-Tender fee (Non Refundable) & bid security (EMD) will be accepted in form of Demand Draft only, in favor of “Rajkot Municipal Corporation”, Rajkot, from any Nationalized or Scheduled bank (except Co-operative Bank) in India.

Pre-Qualification for this work and relevant required certificates / documentary evidence are as below.

i) **Financial Criteria:**

- An average annual turnover of last seven financial years should not be less than 50% of tender amount.
- Working capital should not be less than 25% of the estimated amount.
- Solvency should not be less than Rs.2.00 Lacks

Note: Enhancement factor will be applicable as per tender protocol.

ii) Experience Criteria

1. Bidder should have completed at least one work of similar nature of 60% or two works of 50% of tender amount of either Government or Semi-Government as a main contractor in period of last seven years.
2. The Bidder / firm must have Electrical Contractor License and have registration in E-1 Class with Electrical Division of any State Government / West Government authority.
3. Joint Venture is not permitted.
4. Work of Water Treatment Plant, Sewerage Treatment Plant, Drainage Pumping Stations, swimming Pool, Water Pumping Station, Head works, Mechanical R.C – Electrical R.C shall be considered as similar nature of work and its amount of work shall be considered for tender process.
5. For pre-qualification financial criteria, pro-rata of one year of tender amount will be consider.
6. GST No. to be submitted & it is applicable as per Govt. Norms.
 - After opening of online Technical Bid, the procedure for the pre-qualification shall be adopted and the e-Price Bid of only successful qualified bidder shall be opened for final evaluation of the contract. The decision of Municipal Commissioner regarding the pre-qualification shall be final and binding to all the bidders.
 - Conditional tender will be rejected out rightly.
 - The agency shall also have to submit the documentary evidence for possessing the Electrical Contractor License, having registration of E-1 Class in Government, along with all other required documents during the physical submission within the stipulated date and time. The physical submission shall be made in Sealed Envelope and the name of work shall be super scribed on the top of the Envelope.
 - Technical bid with required documents and certified copies must be submit in physical on or before last date and time by **Reg. A.D. / Speed Post only to Dy. Exe. Engineer (Ele/Mech), Water Works – West Zone, Ele. /Mech. Dept., Room no. 12, First floor, Harisinhji Gohil Bhavan, B/H Big Bazaar 150 ft Ring Road, Rajkot-360005.**
 - The Tender of those bidder(s) who fail to submit the required documents physically within the stipulated date and time will be treated as non-responsive and their Price Bid will not be opened.
 - Price bid and price must be submitted only online n-procure procedure.
 - Bidder who fails to submit the required documents physically, their offer will be treated as

non-responsive.

- The agency should not be Black Listed / Terminated / Debarred or connected with firm black listed in any States, CPWD / MES / Railways or any Govt. Semi-Govt, Autonomous Body or Pvt. Body. Also no complaint is lodged against the Firm / Company, for which, agency will have to submit fresh Notarized Affidavit on stamp paper of Rs. 300.
