1. PREQUALIFICATION CRITERIA

Financial Criteria:

- a. An average annual turnover of last seven financial years should not be less than 50 % of the tender amount of one year.
- b. Working capital should not be less than 25 % of estimated cost of one year.
- c. Amount of Solvency Rs. 2 lacs. A letter from Any nationalized or scheduled bank
- d. Should have work shop with in Rajkot Urban authority area.
- e. Should have PF/ESIC/PT (Professional tax at RMC)/GST/ registration with Govt. body and reg. certificate copy should be accomplice with tender documents.(Wherever applicable)

Experience Criteria:

- A) Financial : Minimum One work of similar nature (annual Maintenance contract of D.G. Sets) with a value of not less then 10.09 lacs or Minimum Two works of similar nature (Annual

Maintenance contract of D.G. Sets) with a value of not less than 8.07 lacs.

B) Technical :

- (1) Should have one work experience for AMC (Annual Maintenance contract of D.G. Sets) of minimum 8 DG sets of minimum capacity 500 KVA or more capacity in last Seven financial years with any Govt or semi-Govt organization in a single work order.

Or

Should have two works experiences for AMC (Annual Maintenance contract of D.G. Sets) of minimum 6 DG sets of minimum capacity 500 KVA or more capacity in last Seven financial years with any Govt or semi-Govt organization in a single work order.

- Enhancement factor at the rate 10% per year for last seven years will be applicable to finalize the magnitude of work done in last seven years.
- Experience certificate of competent authorities should be submitted.
- The agency should not be Black Listed/debarred anywhere in India, for which, agency will have to submit fresh Notarized Affidavit on Rs.300. judicial stamp paper.
- Available Bid Capacity-ABC shall be find out by the following method.

ABC is calculated as $ABC=2(A*N)-B$

Where,

A=Maximum value of works executed in any one year during the last seven years (updated to present price level by applying enhancement factor) taking into account the completed as well as works in progress.

N=Number of years prescribed for completion of the works for which tenders are invited.

B=Value (present price level by applying enhancement factor) of existing commitments and on-going works to be completed during that next N year (period of completion of the works for which the tenders are invited.)

Available Bid Capacity-ABC must be more than the Rs.20.19 lakhs

- All above criteria must be fulfilled by the Agency & its copy of supporting documents certified by Gazetted officer must be submitted with tech bid documents by speed post or Register .Ad. only. Failing which bid evaluation committee will consider the bid as non-responsive & treated as cancelled & price bid of such agency will not be opened. The Technical Bid should be downloaded on a white plain A4 size paper and it should be submitted with all technical details, duly filled and every page should be signed and sealed and should be submitted along with the qualification documents.
- The physical submission must be accompanied by a bid security of Rs 191000 /- as well as e-tender fee(non-refundable) of amount of Rs. 3000/- in form of Demand draft in favor of Municipal Commissioner, Rajkot Municipal Corporation, Rajkot, from any Scheduled bank in India and must be delivered belowon address below:
