 1. Annual turnover average of last seven years should not be less than Rs.6.00 lakh.
 2. Amount of Solvency Rs. 1.00 lakh. A letter from any nationalized or scheduled bank
 3. An experience as main contractor at least one work of similar nature irrespective of amount is completed in last seven years.
 4. Experience certificate of competent authorities, not below the rank of Executive Engineer, required to be submitted.
 5. The agency should not be **black-listed, suspended, terminated, backed-out, debarred and de-listed** anywhere in India, for which, agency will have to submit fresh Notarized Affidavit on Rs. 300 nonjudicial stamp paper.
 6. Agency should have min. working capital of Rs. 1.50 lakh.
 7. Enhancement factor at 10% per year for last seven years will be applicable to arrive and finalize the magnitude of work done, average turnover in last seven years.
 8. All required documents to be submitted in technical bid, for verification, should be duly certified by self. The experience of either government or semi govt. only be considered.
 9. Joint Venture is not permitted for this tender.
