Dept., Room no. 12, First floor, Harisinhji Gohil Bhavan, B/H Big Bazaar, 150 ft Ring Road, Rajkot-360005. from the experienced, & financially sound contractors in either Government or Semi-Government as a main contractor in period of last seven years possessing equipments and having trained technicians for the below mentioned work:

The e-Tender fee (Non Refundable) & bid security (EMD) will be accepted in form of Demand Draft only, in favor of “Rajkot Municipal Corporation”, Rajkot, from any Nationalize or as per bank list G.R of financial department.

The agency submitting the tender shall have to produce documentary evidence for full filling of pre-qualification criteria mentioned in the technical bid. Failing which bid of such agency shall be consider as Non-responsive & stands to cancelled.

After opening of online Technical Bid, the procedure for the pre-qualification shall be adopted and the e-Price Bid of only successful qualified bidder shall be opened for final evaluation of the contract. The decision of Municipal Commissioner regarding the pre-qualification shall be final and binding to all the bidders.

- Conditional Tenders will be out rightly rejected.
- The physical submission shall be made in Sealed Envelope and the name of work shall be super scribed on the top of the envelope.
- Technical bid with required documents & certified copies must be submit in physical on or before last date & time by Reg. A D / Speed post only.
- The Tender of those bidder(s) those who fail to submit the required documents physically within the stipulated date and time may be treated as none responsive and their Price Bid will not be opened.
- Price bid & price must be submit only by online n-procure procedure.

PRE-QUALIFICATION CRITERIA FOR BID EVALUATION

- 1) Bidder who has submitted the details with technical bid will be evaluated for Pre-qualification on the basis of information provided by bidder in performs provided in this volume of tender.
- 2) Pre-qualification will be based on assessing the contractor's ability to carry out the repairing work within the stipulated time.
- 3) The factors affecting the contractors Pre-qualification will be the contractor's experience of carrying out similar works, his financial soundness, equipment and personnel available with him and which he intends to spare for the work put to tender quality of works carried out and performance of similar works carried out by him in the past.
- 4) Tech Bid arriving later than Milestone dates shall not be accepted.
- 5) Tech Bid shall be received by Registered Post / Speed Post only. No hand delivery is permitted.
- 6) The bidder who qualifies by documentary evidence in Pre-qualification, only those bidders shall be informed & Price bid shall be open.
- 7) Rajkot Municipal Corporation team may visit the workshop for qualifying agency to verify location, equipment, tools and instruments, mentioned in the tender by the bidder.

01. Financial capacity of the agency.

1. Average annual turnover of last seven year should not be less than 12.50 lac
Enhancement factor shall be applicable for calculating turnover & financial criteria etc..
2. Minimum working capital should not be less than 6.25 lac for current financial year.
3. Solvency should not be less than 2 lac of current financial year of any nationalized or scheduled Bank located in Rajkot.

02. Experience Criteria.

1. Data given by the bidder must be supported by the work completion certificate or any official government/semi government/public limited company record from competent authority, Data given without such supporting certificate will not be considered.
2. Agency should have completed minimum one work of similar nature work of Rs.15.00 lac or Two work each Rs.12.50 Lacs in any financial year during last 7 year.
3. Experience of repairing of all types of pumps and its accessories of private firm or agencies will not be considered as experience in any form of works.
4. The experience will be taken into consideration only for completed works carried out for Central / State Government agencies, Public Sector Undertaking and Public Limited Company.

Note:- Municipal Services i.e. water works Pumping station, Sewage treatment plant, Drainage Pumping Station, Water Treatment Plant, Swimming pool, Head works, Mechanical maintenance rate contract etc shall be consider as a similar nature work.

03. Availability of tools, plant, & manpower.

1. The agency should have adequate number of tools & plant along with adequate numbers of experienced staff carrying out the work.
(Details of staff & tools with agency must be submitted in tech bid with physical certified certificate copy of the staff.)
2. Joint venture is not permitted.
3. Details Experienced & skilled personnel
4. To produce GST, PF, ESIC Registration and PAN no.
5. Bidder shall have his own service equipment for:
 - a) Equipment handling
 - b) Testing, measuring instruments
 - c) Mechanical tools
