The bid is percentage rate bid for **LAYING AND JOINTING OF A.C.PRESSURE PIPELINE NETWORK ON 9.00 MT. T.P. ROAD ADJOINING SHEETAL PARK MAIN ROAD IN WARD NO.2. (PART-B LABOUR WORK).**

1. The rates and prices shall be submitted in the formats given in the Price Schedules only. Rates and prices received in any other formats will be rejected and the Bids will be disqualified.
2. It will be entirely at the discretion of the Employer to accept or reject the bidder's proposal, without giving any reasons whatsoever.
3. In Price Schedule, bidder shall quote his percentage above/below for items listed in the schedule. Prices quoted in Schedule only will be considered for price evaluation & shall form a part of the Contract Agreement.
4. Only Price Schedule will be considered for financial evaluation of the bid with the successful bidder.
5. The bidder shall be deemed to have allowed in his price for provision, maintenance and final removal of all temporary works of whatsoever nature required for construction including temporary bunds, diverting water, pumping, dewatering etc. for the proper execution of works. The rates shall also be deemed to include any works and setting out that may be required to be carried out for laying out of all the works involved.
6. Where there is a discrepancy between the unit rates and the amount entered, the latter shall govern.
7. The Price Schedules are to be read in conjunction with the Conditions of Contract, the Specifications and other sections of these bid documents and these documents are to be taken as mutually explanatory of one another.
8. Prices quoted by the bidder shall be firm for the entire period of Contract without any escalation.
9. The bidder shall interpret the data furnished and carry out any additional survey work, or investigation work required at his own cost.
10. The prices quoted shall also include the cost of materials utilized for testing.
11. The bidder should acquaint himself with the site conditions including the access to Worksite. The successful bidder shall have to make suitable access to worksites at his own cost. These accesses will be used by the other contractors working for RMC.
12. If material is not available at RMC Store then bidder shall have to supply the same material at Schedule-B rates.
