- **B**=Value (present price level by applying enhancement factor) of existing commitments and on-going works to be completed during that next N year (period of completion of the works for which the tenders are invited.)

03. Availability of tools, plant, & manpower.

- 1. The agency should have adequate number of tools, safety kits & plant along with adequate numbers of experienced staff for carrying out the work. (Details of staff & tools with agency must be submitted in tech bid.)
- 2. Joint venture is not permitted.

04. Notarized copy of certificates/Documents as followed must be physically submit with authorized sign & stamp on each page oftech bid document

- 1. The bidder / firm must have Electrical Contractor License and have registration in Class "E2" with Electrical Division of R&B of Gujarat state or in equal class of any State Government /Central Government or local self gov. authority.
- 2. Valid Electrical contractor license.
- 3. PAN No. registration
- 4. ESIC / PF/ GST Registration certificate.
- 5. Labor license under Contract labor act 1970 (Past work) If applicable
- 6. Professional tax registration certificate.
- 7. Chartered accountant certified copy for the turnover for last seven year supporting financial strength of the bidder.(Which showing turnover as well as working capital)
- 8. Solvency certificate from any Nationalize or Schedule bank (Except co-op bank)

- 10. Power of Attorney authorizing the person for signing the Tender and give any clarification asked by department in case of other than proprietary firm.
