- The e-Tender fee will be accepted in form of Demand Draft only, in favour of "Rajkot Municipal Corporation", Rajkot, from any Nationalized Bank or Scheduled bank (except Co-operative Bank) in India and must be delivered to above address.
- **The bidder(s) submitting the tender shall also have to submit the copy of ESIC & EPF Registration document along with the other documents, duly self-attested, failing which, the tender of such bidder(s) will be considered as non-responsive and their online price bid will not be opened.**
- **The Pre-Qualification requirement is as under: -**
 - (A) Financial Criteria**
 1. An average annual turnover of seven years should not be less than 50% of tender amount.
 2. Working capital should not be less than 25% of the estimated amount.
 3. Bidder must have minimum **"C" Class registration**
 4. Bank Solvency should not be less than Rs. 25.00 lacs.
 - (B) Experience Criteria:**
Experience of having successfully completed similar works during last 7 years should be either of the following
 - i) **Two** similar works costing not less than the amount equal to **30%** each of the estimated cost.
 - OR**
 - ii) **One** similar completed works costing not less than the amount equal to **40%** each of the estimated cost.
 - (C) Definition of similar works:**
Structure like Crematorium Building, Sports Complex, Exhibition and Convection Centres (Auditorium), Large Institutional Building works consisting of RCC Frame Structures including water supply, sanitary, General Electrification etc. for any of Government, Semi-Government. The experience of construction for Private Builders / Societies will not be considered.
 - (D) Eligible Criteria:**
The contractor should have executed Gas/Electric based cremation furnace in project of Government/Semi-Government. The contractor should submit required experience certification (Form No.3A) issued by the Government/Semi-Government.

Note:

1. Enhancement factor at 10 % per year for last seven years will be applicable to arrive average annual turnover and finalize the magnitude of work done in last seven years.
2. Available Bid Capacity-ABC will be finding out by the following method.

Available bid capacity = (A x N x 2) – B, where

A = Average value of Civil engineering works executed of last seven years(Updated to present price level by applying enhancement factor)

B = Value at 31-12-2021, Price level of existing commitments and on-going works to be completed during the next two years.

N = Number of years prescribed for completion of the works for which the bids are invited.

3. Joint-Venture will be permitted.
4. Documents to be submitted with the Techno-commercial Bid: - The bidder shall submit supporting documents for the product offered by him in the bid as per following list.
 - Datasheets for electrical and mechanical properties indicating all the parameters specified in the detailed Scope of Work.
 - All IEC certificates and other certificate(s) as applicable. Required by RMC
5. The bidder must be registered as an Electrical contractor with any state government or central government.
 - a. The bidder must submit the copy of PAN registration.
 - b. The bidder must submit the fresh "NO BLACK LIST" Affidavit on duly notarized Rs. 300/- Stamp Paper stating that the bidder is never black listed in any of the Govt. or Semi Govt. departments of any state or India.
 - c. The bidder must submit the copy of the valid GST registration.
 - d. The bidder must submit the copy of the valid PF registration.
 - e. The bidder must submit the copy of Memorandum of Association or Partnership Deed, as the case may be.
 - f. Conditional tender shall not be accepted and will be rejected.
 - g. Acceptance of the tenders will rest with The commissioner, RAJKOT MUNICIPAL CORPORATION, Rajkot, who does not bind himself to accept the lowest tender and reserves the right to reject any or all tenders without assigning any reason thereof.
 - h. For any legal matter/disputes the jurisdiction will be Rajkot.
 - i. All the Tender documents/ bid documents/ Amendments/ Corrigendum/ Addenda / copies must be self certified/ signed with stamp at every page by the bidder.
 - j. Documents to be submitted with the Techno-commercial Bid: - The bidder shall submit supporting documents for the product offered by him in the bid as per following list.
 1. Datasheets for electrical and mechanical properties indicating all the parameters specified in the detailed Scope of Work.
 2. All IEC certificates and other certificate(s) as applicable. Required by RMC

5. Firm should not be with Black listing History with Govt., Semi Govt., Boards and Corporations. Notarized Affidavit in this regard should be submitted on **Rs.300/- Stamp Paper/Required amount stamp paper as per prevailing law.**
6. The contractor shall have to quote their rates including GST and other taxes and the Invoice with break-up of GST is to be submitted accordingly, failing which, such amount will be deducted from the bill of the agency and deposited accordingly. The contractor shall have to purchase the material required for this tender work, only from the supplier having registered GST Number. RMC will not be responsible to pay any amount towards GST if the material is purchased from the unregistered supplier / not having GST Number.
7. The bidder(s) submitting the tender shall also have to submit the copy of ESIC & EPF Registration document along with the other documents, duly self-attested, failing which, the tender of such bidder(s) will be considered as non-responsive and their online price bid will not be opened.
8. The firm must give an affidavit through its directors/Partners/Prop. Stating that all the credentials/Documents submitted are true and genuine and if found false at any stage of the project, they are liable for all the financial or legal consequences on this account.
9. After opening of online Technical Bid, the procedure for the pre-qualification shall be adopted and the e-Price Bid of only successful qualified bidder shall be opened for final evaluation of the contract. The decision of Municipal Commissioner regarding the pre-qualification shall be final and binding to all the bidders.
10. The Tender of those bidder(s) those who fail to submit the required documents physically within the stipulated date and time will be treated as non-responsive and their e-Price Bid will not be opened.
11. Conditional Tenders will be out rightly rejected.
12. Rajkot Municipal Corporation, Rajkot, reserves the right to accept / reject any or all e-Tender(s) without assigning any reasons thereof.
13. Any queries regarding tender scope shall be submitted prior to 1 days of pre-bid meeting via E-mail. Queries received after Pre Bid Meeting will not be entertained.
