All bidders must submit tender fee and a bid security in person as above either directly deposited in ICICI Bank Account No.015305010638 (Rajkot Municipal Corporation) IFSC Code ICIC0000153 or submit at below mentioned address only in form of DD and DD/FDR/BG respectively in favor of "Rajkot Municipal Corporation", Rajkot, from any Nationalized OR Scheduled Bank (except yes bank and Cooperative Bank) in India. The DD/FDR/BG No., date and name of the bank, branch shall have to be mentioned online and subsequently same shall have to be submitted during physical submission along with required documents. The tender of those bidders who fails to submit documents or to produce the originals for verification within time schedule for these tenders will be out rightly rejected.

2. The pre-qualification requirement is as under:

Minimum Eligibility Criteria:-

For eligibility, the bidder shall fulfill following criteria.

I. single bidder also permitted for bidding.

For works having amount put to tender equal to or more than Rs. 50 crores

As per above, Or

Bidder can be Joint Venture of not more than 2 firms

Lead partner firm should have valid registration as per eligibility criteria.

Lead partner must have not less than 51% financial participation and other member must have not less than 20% financial participation (total should be 100%)

No firm can bid for a given work simultaneously as separate bidder and as a member of joint venture. Both the firm and joint venture shall stand disqualified in such case.

- II. Contractor registered with Government Railway, MES, PWD and CPWD in class 'AA' category and special Category-1 for bridges, contractors registered in Other State Government/ Central Government in appropriate class and meeting the qualifying criteria as specified.
- III. Experience and financial criteria will be applicable as per share in JV.
 - A. Financial Criteria:
- (a) Annual Turn Over
 - i. Average Annual turnover of last Seven financial years shall be not be less than 50 % of tender amount.
 - ii. For arriving at updated value, turnover of any financial year shall be multiplied by the enhancement factor corresponding to that year.
 - iii. For joint venture, the lead partner must have average annual turnover of last seven years not less 40% of tender amount of similar work and remaining of other partner must have updated average annual turnover of last seven years not less than 20%.

The joint venture must collectively have updated average annual turnover as per share in JV. Turnover

shall be considered according to bidders' share in JV.

- iv) Working capital should not be less than 25% of the estimated tender amount.
- v) Solvency must not be less than Rs. 300 Lacs
- vi) Available bid capacity- ABC must be more than the estimated tender amount

ABC is to be calculated as - ABC = 2*A*N-B

A = Maximum Value of works executed in any one year during the last seven years (updated to present price level by applying enhancement factor) taking into account the completed as well as works in progress.

N = No. of Years prescribed for completion of the work for which tender is invited

- B = Value (*Price level) of existing commitments and ongoing works to be completed during the next N Years (Period of completion of the work for which the tender is invited).
- The bidder(s) submitting the tender shall also have to submit the copy of ESIC & EPF Registration document along with the other documents, duly self attested, failing which, the tender of such bidder(s) will be considered as non-responsive and their online price bid will not be opened.xperience Criteria:

The bidder should possess the following minimum experience.

a) Bidder should have completed at least one work of similar nature of 60% or two works of 40% or three works of 30% each of tender amount is completed in last seven years.

Similar nature work shall mean construction of Fly over bridge (FOB) or

Railway over bridge (ROB) with Precast/PSC/Composite girder.

Additionally the agency should have carried out the followings:

- i. Open foundation in rocky strata, Pile foundation, well foundation for any bridge work
- ii. At least one completed work of 20m or larger span of RCC box / RCC/Precast/Steel/Composite Girder for 2 or more lane vehicular traffic.
- b) Bidder should have enough machinery and experienced personnel to supervise the work.

In JV, lead partner must qualify the similar experience, registration documents or another partner may or may not qualify the clause (a) above..

Note: - Enhancement factor at 10% per year for last seven years will be applicable to arrive at average annual turnover and finalized the magnitude of work done in last seven years. Year 2023-24 shall be effective as base with zero enhancement i.e 1.0.

- C) The Tender of those bidder(s) those who fails to submit the required verification within the stipulated date and time, will be treated as non-responsive and their Price Bid will not be opened. The date physical and submission of required documents received after the prescribed time will be out rightly rejected.
- D) The bidder should not have been Black Listed, suspended, terminated, backed out, debarred & delisted by any Municipal Body / Urban Local Body / Development Authority in any State Government Body or undertaking /

any department or undertaking of Government of India, since inception of the firm / Company. Such a case will be rejected out rightly. A Declaration in this regard on Rs.300/- Stamp Paper duly Notarized shall have to be submitted as per Annexure along with the tender documents. Submission of the bid document without such Notarized declaration will be rejected out rightly.

- E) The bidder should provide accurate information on any litigation history or arbitration resulting from contracts completed or under execution by him over the last ten years. This should also include such cases, which are in process / progress. A consistent history of awards against the bidder may result in failure of the bid. In case the bidder has not provided such information and has come to the notice of the authority, the tender will be rejected at what so ever stage and in such case all the losses that will arise out of this issue will be recovered from the tenderer / bidder and he will not have any defense for the same.
- F) After opening of Technical Bid, the procedure for the pre-qualification shall be adopted and the Price Bid of only successful qualified bidder shall be opened for final evaluation of the contract. The decision of Municipal Commissioner regarding the pre- qualification shall be final and binding to all the bidders.
- G) Conditional Tenders will be out rightly rejected.
- H) The contractor shall have to quote their rates without GST and including other taxes applicable. The invoice should be submitted by contractor showing the breakup of GST in the submitted bill. The contractor shall have to purchase the material required for this tender work only from the supplier having registered GST number. RMC shall not be responsible to pay any amount towards the GST if the material is purchased from the unregistered supplier not having GST number.
- I) After opening of Technical Bid, the procedure for the pre-qualification shall be adopted and the Price Bid of only successful qualified bidder shall be opened for final evaluation of the contract. The decision of Municipal Commissioner regarding the pre- qualification shall be final and binding to all the bidders.
- J) The bidde(s) submitting the tender shall also have to submit the copy of ESIC & EPF registration document along with the other documents duly self-attested ,failing which the tender of such bidder(s) will be considered as non-responsive and their on line price will not be opened.
- K) After the opening of Technical Bid, the procedure for the pre-qualification shall be adopted and the Price Bid of only successful qualified bidder shall be opened for s evaluation of the contract. The decision of Municipal Commissioner regarding the pre-qualification shall be final and binding to all the bidders.
- L) The Tender of those bidder(s), those who fail to submit the required documents physically within the stipulated date and time will not be accepted, will be treated as non-responsive and their Price Bid will not be opened.
