3. Rajkot Municipal Corporation has right to depute Qualified Bidder as per below.

- (a) If any agency's bid is selected as L1 in more than one tender out of 3 tenders (PHASE-(IV), (V), and (VI)), only the work with the lowest rate will be considered, and that lowest rate single tender will be allotted to that agency.
- (b) If any bidder is qualified as L-1 in more then one tenders out of 3 tenders (PHASE-(IV), (V), and (VI)then remaining two tenders will be given to any one agency L-2, L-3, L-4, Respectevily whichever agency ready to be agreed works at L-1 agency's bid price.
- (c) If L-1 agency fails to complete the allotted work, the remaining quantity will be reassigned to L-2, L-3, L-4 respectively which ever agency ready to be agreed works at L-1 agency's bid price.
- (d) RMC provides a maximum of 2.5 lac tons of legacy waste or the available quantity at the site, whichever is lower.
- (e) Agency shall give disposal planning of RDF before the agreement as per MSW-rules-2016.
- While furnishing Experience Data & Bank Documents, the agency submitting the tender shall have to provide the Contact Address, Phone No., Fax No, e-mail address of the

authorities issuing the Experience Certificate for confirmation by this office. In case of failure of confirmation, the tender will be liable to be rejected out rightly.

- Technical Proposal Signed Documents shall be submitted in electronic format only through online by scanning. The E-tender with signed and stamp, Pre-proposal Minutes of the Meeting, Addendums issued, Work Experience Certificate, Financial documents (turn over, working capital, networth), company profile, pancard, GST certificate, solvency and all necessary documents etc., shall be submitted online only without any financials.
- After opening of online Technical Bid, the procedure for the pre-qualification shall be adopted and the e-Price Bid of only successful qualified bidder shall be opened for final evaluation of the contract. The decision of Municipal Commissioner regarding the prequalification shall be final and binding to all the bidders.
- The Tender of those bidder(s) those who fail to submit the required documents online within the stipulated date and time will be treated as none responsive and their Price Bid will not be opened and RMC will not be liable for the same.
- The bidder should not have been Black Listed or debarred by Government of India / Government of Gujarat or any State Board / Corporations, since inception of the firm / Company. A Declaration in this regard on Rs.300/- Stamp Paper duly Notarized, shall have to be submitted as per format Annexure, along with the tender fee and EMD fee physically submitted RMC office through Regd. AD / Speed post. failing in which will be automatically rejected and disqualified.
- The bidder should provide accurate information on any litigation history or arbitration resulting from contracts completed or under execution by him over the last ten years. This should also include such cases, which are in process / progress. The bidder must provide such information to the authority.
- Conditional Tenders will be out rightly rejected.
- Professional Tax, EPF, ESIC,GST, Contract Labour Act statutory Registration must be compulsory wherever applicable.
