Preliminary Inspection of Raw Material of Low Bed Trailer shall be carried out by authorized representative of Rajkot Municipal Corporation & TPI , Final inspection will be carried out at supplier premises before dispatch of the Low Bed Trailer and Tractor trolley on the intimation from supplier. Third Party inspection agency nominated by RMC and the charges(TPI Fees approx 0.45% of Contract Value) for the same(Whatever is charged by TPI Agency)and travel, accommodation, food, etc of tpi and representatives of RMC during Inspection has to borne by tenderer.

20. PRICE PREFEENCE:

No price preference will be given to SSI units or Khadi Gramudhyog Units.

21. JURISDICTION:

In the event of any dispute or difference arising out of this e-tender / contract, the jurisdiction of the Court shall be Rajkot (Gujarat) only. While executing the agreement, the supplier shall be governed at all times by all laws, regulations etc., in force in Gujarat State.

22. DISPUTE:
