1. Two-bid procedure will be adopted. Bidders are to submit online details simultaneously; one containing the technical proposal and one containing the price proposal. Initially only the technical proposals will be opened. Technical proposals which are submitted by non-qualified bidders or which are not substantially responsive will be rejected.

1. Financial Criteria:

- a) The applicant must have achieved a minimum annual turnover (defined as billing work in progress and completed in all classes of civil engineering construction works only) in any one year over the last seven financial years of the.(i.e. 109 lakhs, Enhancement factor shall be apply as per RMC

- rules)
- b) Working capital should not be less than 25% of estimated cost. (i.e. 27.25 lakhs.)
- c) Available Bid Capacity-ABC must be more than the estimated cost.

2. Experience Criteria.

Experience of supply of this kind of safety equipment, minimum value of 43.60 Lacs in anyone year of last seven years in single contract for Govt. or Semi Govt. Organization.

If the bidder is manufacturer then shall have a full-fledged workshop with all equipment's, machineries and manpower and if the bidder is supplier then his parent company shall have a full-fledged workshop with all equipment's, machineries and manpower and for imported equipment bidder must have local service workshop along with backup Support/guarantee certificate from his parent company.

- b. Available Bid Capacity-ABC shall be find out by the following method. ABC is calculated as $ABC=2*A*N-B$

Where,

A=Maximum value of works executed in any one year during the last seven years (updated to present price level by applying enhancement factor) taking into account the completed as well as works in progress.

N=Number of years prescribed for completion of the works for which tenders are invited.

B=Value (present price level by applying enhancement factor) of existing commitments and on-going works to be completed during that next N year (period of completion of the works for which the tenders are invited.)

3. **Availability of tools, plant, & manpower.**

- a. The agency and OEM should have adequate number of tools, safety kits & plant along with adequatenumbers of experienced staff for carrying out the work.

4. The bidder(s) submitting **the scan copy of documents online on website <https://rmctender.nprocure.com>**, failing which, the tender of such bidder(s) will be considered as non-responsive and their online price bid will not be opened.

5. The contractor shall have to quote their rates Including GST and with other taxes and the Invoice with break-up of GST is to be submitted accordingly, failing which, such amount will be deducted from the bill of the Bidder and deposited accordingly.

Terms & Conditions:

2. Conditional tender are liable to be rejected.
3. Joint venture or MOU is not permitted.
4. The bidder should provide accurate information on any litigation history or arbitration resulting from contracts completed or under execution by him over the last ten years. This should also include such cases, which are in process/progress. A consistent history of awards against the bidder may result in failure of the bid. In case the bidder has not provided such information and has come to the notice of the authority, the tender will be rejected at what so ever stage and in such case all the losses that will arise out of this issue will be recovered from the tenderer/bidder and he will not have any defense for the same.
5. Enhancement factor at 10% per year for last seven years will be applicable to arrive average annual turnover and finalize the magnitude of work done in last seven years.
6. The agency should not be Black Listed/Debar/Terminated anywhere in India, for which, agency will have to submit fresh Notarized Affidavit on Rs.300/- judicial stamp paper.
7. Sites visit & fully aware with nature of work confirmation letter
8. Power of Attorney authorizing the person for signing the Tender and give any clarification asked by department.
9. The contractor shall have to purchase the material required for this tender work, only from the supplier having registered GST Number. RMC will not be responsible to pay any amount towards GST if the material is purchased from the unregistered supplier / not having GST Number.
10. The successful bidder shall have to pay security deposit amounting to 5% of Contract Value in favour of "Rajkot Municipal Corporation" in terms of Fixed Deposit Receipt of Nationalized Bank or as per Finance Department, GR No.- FD/MSM/e-file/4/2023/4020/DMO, Dt.11/03/2024 valid for the period of 15 Months.
11. **If the contract price offered by the selected bidder is lower than 10% but up to 20% of the Estimated project Cost than the additional performance security shall be calculated @20% of the difference in the Estimated Project Cost minus 10% of the Estimated Project Cost and Contract Price offered by the selected Bidder.
If the contract price offered by the selected bidder is lower than 20% of the Estimated project Cost than the additional performance security shall be calculated @30% of the difference in the Estimated Project Cost minus 10% of the Estimated Project Cost and Contract Price offered by the selected Bidder.
The Additional Performance Security shall be treated as part of the Performance Security. The Performance Security shall be valid beyond 60 days of the defect liability period and the additional Performance Security shall be valid beyond 28 days of Project completion Date.**
12. The Tender of those bidder(s) those who fails to submit the required documents

physically within the stipulated date and time, will be treated as non responsive and their Price Bid will not be opened.

13. After opening of Technical Bid, the procedure for the pre-qualification shall be adopted and the Price Bid of only successful qualified bidder shall be opened for final evaluation of the contract. The decision of Municipal Commissioner regarding the pre-qualification shall be final and binding to all the bidders.
14. After opening of the Technical Bid, if the agency is disqualified for this work and under such circumstances if the agency tries to pressurize the Evaluation Committee through any means then the offer of such bidder will be treated non-responsive and liable to be rejected out rightly without assigning any reason thereof.
15. Enter into an agreement on stamp paper as per prevailing norms. It shall be incumbent on the Contractor to pay the stamp duty and the legal charges for the preparation of the contract agreement.
16. The Jurisdiction will be Rajkot City only.
