(2) The pre-qualification requirement is as under:

i) Financial Criteria:

- ii) The bidder must have achieved a minimum annual turnover in any one year over the last seven financial years (i.e. 2023-24 to 2017-18) of the annual value of contract applied for. (i.e., Rs. 65,30,300/-)(Rajkot Municipal Corporation's Enhancement Factor will be applicable.)
- iii) The bidder has liquid assets (aggregate of Working capital, cash in hand and uncommitted bank guarantees) and/or credit facility equal to 25% of the contract value. (i.e. Rs. 16, 32,600/-)
- iv) Available Bid Capacity-ABC must be more than the tender amount.

ii) **Experience Criteria:**

The bidder should possess following minimum experience:

- A. Experience in successfully completing or substantially completing at least one contract of similar nature of work of at least 40 percent (i.e 26.13 lakh) of the estimated tender of the value of proposed contract within the last seven years of either Government / Semi-Government as a main contractor. Experience certificate of competent authorities required to be submitted.
- B. The works may have been executed by the applicant as prime contractor or as a member of a joint venture. In case a project has been executed by a joint venture, weight towards experience of the project would be given to each joint venture in proportion of their final participation in the joint venture.
- C. The bidder should further have experience of successful completion of O&M of minimum one sewage/water pumping station/STP/WTP out of the "work similar nature" completed by bidder as specified above as (A) and considered by bidder for pre-qualification experience criteria for similar nature of works shall be for at least one year.
- D. Bidder shall be registered in GWSSB / State Government / Central Government in Class 'D' and above of Electrical Department or shall be an original pump manufacturer of approved make having experience of similar work as specified above at A.
- E. Copy of original certificates duly notarized(original notarized copy) in support of above requirements shall be enclosed in hard copy for verification, certified by the respective employer or his authorized representative, not below the rank of an Executive Engineer or equivalent. Original Certificates of the same shall be produced for verification on demand by employer, failing which, will result in to rejection of tender.
- F. For the purpose of bid evaluation, the owner/owner's representatives if feel necessary to visit a specific or all such pumping stations as mentioned above by the bidder, the bidder shall make necessary arrangements/approvals for the same. Cost for the same shall be borne by the bidder.
- G. Note: Enhancement factor at 10% per year for last Seven years will be applicable to arrive annual turnover and finalize the magnitude of work done in last seven years.

The physical submission must be accompanied by a EMD of Rs. 65,500/- as well as etender fee (non-refundable) of amount of Rs.3000/- in terms of Demand draft in favor of Municipal Commissioner, Rajkot Municipal Corporation, Rajkot, from any Nationalized Bank or as per Finance Department, GR No.-FD/MSM/e-file/4/2023/4020/DMO, Dt.11/03/2024 and must be delivered within seven days from the last day of submission of bid. - 3. Joint venture or MOU is not permitted.
- 4. The bidder should provide accurate information on any litigation history or arbitration resulting from contracts completed or under execution by him over the last ten years. This should also include such cases, which are in process/progress. A consistent history of awards against the bidder may result in failure of the bid. In case the bidder has not provided such information and has come to the notice of the authority, the tender will be rejected at what so ever stage and in such case all the losses that will arise out of this issue will be recovered from the tenderer/bidder and he will not have any defense for the same.

- 5. Enhancement factor at 10% per year for last seven years will be applicable to arrive average annual turnover and finalize the magnitude of work done in last seven years.
- 6. The agency should not be Black Listed/Debar/Terminated /Suspended anywhere in India, for which, agency will have to submit fresh Notarized Affidavit on Rs.300/- judicial stamp paper.
- 7. Sites visit & fully aware with nature of work confirmation letter
- 8. Power of Attorney authorizing the person for signing the Tender and give any clarification asked by department.
- 9. The agency shall also have to submit the documentary evidence for possessing the Current Electrical Contractor License in Electrical Department of Government.
- 10. The contractor shall have to purchase the material required for this tender work, only from the supplier having registered GST Number. RMC will not be responsible to pay any amount towards GST if the material is purchased from the unregistered supplier / not having GST Number.
- 11. Also, the details of works on hand and works completed shall have to be mentioned in the Annexure-II of Technical Bid (Volume-I)
- 12. The successful bidder shall have to pay security deposit amounting to 5% of Contract Value in favour of "Rajkot Municipal Corporation" in terms of Fixed Deposit Receipt of Nationalized Bank or as per Finance Department, GR No.-FD/MSM/e-file/4/2023/4020/DMO, Dt.11/03/2024 valid for the period of 66 Months.

If the contract price offered by the selected bidder is lower than 10% but up to 20% of the estimated project Cost than the additional performance security shall be calculated @20% of the difference in the Estimated Project Cost minus 10% of the Estimated Project Cost and Contract Price offered by the selected Bidder.

If the contract price offered by the selected bidder is lower than 20% of the estimated project Cost than the additional performance security shall be calculated @30% of the difference in the Estimated Project Cost minus 10% of the Estimated Project Cost and Contract Price offered by the selected Bidder.

The Additional Performance Security shall be treated as part of the Performance Security. The Performance Security shall be valid beyond 60 days of the defect liability period and the additional Performance Security shall be valid beyond 28 days of Project completion Date.

- 13. The Tender of those bidder(s) those who fails to submit the required documents physically and online within the stipulated date and time, will be treated as non-responsive and their Price Bid will not be opened.
- 14. After opening of Technical Bid, the procedure for the pre-qualification shall be adopted and the Price Bid of only successful qualified bidder shall be opened for final evaluation of the contract. The decision of Municipal Commissioner regarding the pre-qualification shall be final and binding to all the bidders.
- 15. After opening of the Technical Bid, if the agency is disqualified for this work and under such circumstances if the agency tries to pressurize the Evaluation Committee through any means then the offer of such bidder will be treated non-responsive and liable to be rejected out rightly without assigning any reason thereof.

- 16. Enter into an agreement on stamp paper as per prevailing norms. It shall be incumbent on the Contractor to pay the stamp duty and the legal charges for the preparation of the contract agreement.
- 17. The Jurisdiction will be Rajkot City only.
