2.0 Two Bid document bidding procedure will be adopted. Bidders are to submit the required online details electronically. Initially only the technical proposals are opened. Technical proposals which are submitted by non-qualified bidders or which are not substantially responsive will be rejected. The price proposals of only responsive bidders will be opened.

3.0 All bids must be accompanied by a bid security of Rs.35,780/- (Rs.Thirty five thousand seven hundred eighty Only) in form of Demand draft from any Nationalized Bank or Scheduled bank (except Co-operative Bank) in India, in favour of **Commissioner, Rajkot Municipal Corporation, Rajkot** and must be delivered to

4.0 Physical submission of EMD and tender fees as well as other documents asked is to be submitted within the stipulated date and time. Verification of submitted documents (EMD, e-Tender fees and other documents asked) will be done accordingly.

5.0 The bid security and appendix details must be included with the physical submission of technical proposal.

6.0 If possible, the technical proposals will be opened on given date and time in the presence of bidders' representatives who choose to attend.

7.0 The price proposals will be opened in the presence of the bidder's representatives who choose to attend at the time and date and at *the* address to be advised by the Employer after approval of the evaluation of the technical proposals.

8.0 Pre-qualification criteria of the bidder will be as under:

**Evaluation Criteria:**

a. Financial Criteria:

- (1) An average annual turnover of last seven years should not be less than the 50% of estimated cost
- (2) Working capital should not be less than 25% of estimated cost.
- (3) Solvency should not be less than Rs.2.00 lacs.

b. Experience Criteria:

The bidder should possess following minimum experience

1. Bidder to provide supporting documents of having completed satisfactorily at least one work of similar nature of **60%** or two works of **50%** each of tender amount, and in a single contract of ESR (i.e. on his own design ) for either government or Semi-government as a main contractor in the past 7 years.
  2. Bidder should have an experience of design build and commissioning of ESR having minimum capacity 2.0 lacs liters with 12 mt staging height and completed satisfactorily at least one ESR of 2.0 lakh capacity work either of government or Semi-government as a main contractor in last 7 years.
  3. Bidder should have enough machinery, centering of particular work and experienced engineering personnel to supervise the work. Its documents to be provided with bid.
  4. Bidder shall have a registration with State or Central Government Semi-government in appropriate class i.e E-1 Class.
- 9.0 The contractor shall have to quote their rates including GST and other taxes and the Invoice with break-up of GST is to be submitted accordingly, failing which, such amount will be deducted from the bill of the agency and deposited accordingly. The contractor shall have to purchase the material required for this tender work, only from the supplier having registered GST Number. RMC will not be responsible to pay any amount towards GST if the material is purchased from the unregistered supplier / not having GST Number.
- 10.0 The tender(s) of those bidders who fail to submit the required documents physically within the stipulated date and time, will be treated as non-responsive and their Price Bid will not be opened.
- 11.0 Municipal Commissioner, Rajkot Municipal Corporation, Rajkot, reserves the right to accept / reject any or all tender(s) without assigning any reason thereof.
