CHAPTER – 3

:: General Terms And Conditions For Contract ::

- 1. Quoted price should be inclusive of all taxes and duties like GST, To & Fro, Transportation charges,
- 2. e-Tender shall be valid for a period of not less than 145 days after the date of opening e-Tender Price Bid.
- 3. The award of contract will normally be made within 120 days after the date of opening e-Tender Price Bid.
- 4. e-Tender will be submitted online through e-tendering as per milestone dates and etendered Technical Bid will be opened on as per milestone dates on web site <u>http://www.rmc.nprocure.com</u>
- 5. e-Tenderer should have to offer the firm prices in e-tender Price Bid for the prescribed item as per given in Technical Specification. Offer for the other item will not be considered and tender will be rejected.

6. QUALIFICATION/ELIGIBILITY CRITERIA

A. Manufacturer license should be provided

В.

Manufacturer &/or Supplier of such type of Weigh bridge or its authorized dealer/ distributor can take part in the tender for which necessary documentary proof should be enclosed with tender. If the Bidder is Authorized dealer/ Distributor of the manufacturer, a latest Authority letter should be submitted. Necessary documentary proof shall be attached with the tender.

C. GST certificate should be provided

D. Financial Criteria:

- a. The Average Annual financial turnover of the bidder during the last 7 years, ending 31/03/18 should be at least Rs.2.95 Lakhs. Separate Chartered Accountant's certificate shall be attached.
- **b.** The bidder/Companies must have solvency certificate of Nationalized/Schedule Bank amounting to not less than **Rs. 1 Lakh**. The solvency certificate issued shall not be more than one year old.

E. Experience Criteria:

Bidder should have completed similar type of work such as installation or repairing of any type of Weigh Bridge in Government or semi-government or ULB in last 7 years. Work order should be attached.

7. Disqualification

Even though the Applicants meet the above criteria, they are subject to be disqualified and forfeiture of EMD (with approval of competent authority) and agency will be debarred from RMC, if Applicant or any of its constituent partners/ consortium member has:

Made misleading or false representation in the forms, statements, and attachments submitted; or

Been debarred by Central govt. organization/ State govt. organization/RMC or any other Agency of Government of India or any of the State Governments/ULBs. In case of a proprietary firm, partnership firm the following are the disqualification criteria:

- (i) If, any of the member/partner or the proprietor is debarred by Central govt. organization/ State govt. organization /RMC or any other Agency of Government of India or any of the State Governments/ULBs.
- (ii) If, any of the partners or the proprietor has a criminal history or has been convicted by any court of law for any of the offenses under any Indian laws.
- iii) If, any criminal proceeding is pending in any court of law in India against any of the partner or a proprietor and if any such proceeding culminates into conviction in last seven years.

Note: The experience as sub contractor shall not be considered.

- 8. On award of contract, the successful bidder will have to produce an F.D.R. of any Scheduled or Nationalized Bank of Rajkot City 5% of the supply cost of the work, towards the security deposit, in favour of Rajkot Municipal Corporation, must be submitted in the S.W.M. Branch. An agreement deed in favour of Rajkot Municipal Corporation on the Stamp Paper of 4.90% of FDR amount must be submitted. And if the contractor fails to submit the agreement deed in the stipulated time limit, the E.M.D. for this contract will be forfeited and the contractor will be black listed for this work of RMC. This will be returned only after successful completion of warranty period.
- 9. Bidder will have to complete the work within 30 working days from the date of work order otherwise penalty of Rs. 500/- per day will be charged.
- 10. Any modification or any changes in work or technical specifications done by RMC's Engineer-In-Charge or Third Party Inspecting Agency and e-tenderer have to follow these changes without any dispute and argument. (No extra cost will be given for the modifications or changes).
- 11. The Technical Bid should be downloaded on a white plain A4 size paper and it should be submitted with all technical details with quoted models and leaflet, duly filled and every page should be signed and sealed and should be submitted along with the qualification documents.

12. PRICE PREFEENCE: No price preference will be given to SSI units or Khadi Gramudhyog Units.

13. JURISDICTION:

In the event of any dispute or difference arising out of this e-tender / contract, the jurisdiction of the Court shall be RAJKOT (Gujarat) only. While executing the agreement, the supplier shall be governed at all times by all laws, regulations etc., in force in Gujarat State.

14. **DISPUTE:**

In the event of any problem, dispute or difference arising out of or under this contract, the decision of the Municipal Commissioner, RAJKOT MUNICIPAL CORPORATION, RAJKOT, will be final and binding to the parties to this contract.

15. NON-BLACK LISTING BOND:

The Tenderer has to furnish the undertaking on the non-judicial stamp paper of Rs.100/- duly Notarized regarding his firm is not black listed in anywhere in India at the time of e-tendering. This undertaking should be submitted during the physical submission of Qualification documents.

16. GUARANTEE:

The supplier at the time of entering into contract shall give a guarantee against technical and manufacturing defects in materials supplied and free replacement of defective materials at his own cost up to a period of 12 months from the date of receipt of material.

- 17. Municipal Commissioner, RAJKOT MUNICIPAL CORPORATION, RAJKOT, reserves the right to accept or reject any or all the e-tender(s) without assigning any reasons thereof.
- 18. Technical Bid will be opened as per milestone dates and after evaluation of Technical Bid, Price Bid will be opened only of those e-tenderers who will be qualified in Technical Bid evaluation. Date of opening of Price bid will be as per milestone dates onwards, only of those e-tenderers who will be qualified in e-technical bid evaluation.

19. Warranty:

Supplier shall provide a warranty of 12 (twelve) months from the date of supply.

- 20. Tender fees will not be refunded under any circumstances.
- 21. Bidders shall submit necessary registration certificate like GST number registration copy & any other if required for execution of such work as per government rules along with tender document.
- 22. At any time prior 24 hours to the last date and time of submission of Bids RMC may, for any reason, whether at its own initiative or in response to clarifications requested by any Supplier, modify the tender by the issuance of Addenda. All interested tenderer shall have to check the www.rmc.nprocure.com. The Bidder shall not transfer the TENDER document to another interested party
- 23. The EMD shall be forfeited in the following cases:
 - (a) If the Supplier withdraws its Bid during the interval between the Bid Due Date and expiration of the Bid Validity Period.

(b) If the successful supplier fails to provide the Performance Security within the stipulated time or any extension thereof provided by RMC;

24. Evaluation

- (1) As part of the evaluation, the Bids shall be checked for responsiveness with the requirements of the tender and only those Bids, which are found to be responsive, would be further evaluated in accordance with the criteria, set out in this tender.
- (2) It provides information in reasonable detail. ("Reasonable Detail" means that, but for minor deviations, the information can be reviewed and evaluated by RMC without communication with the Supplier). RMC reserves the right to determine whether the information has been provided in reasonable detail.
- (3) There are no inconsistencies between the Bid and the supporting documents. A Bid that is substantially responsive is one that confirms to the preceding requirements without material deviation or reservation. A material deviation or reservation is one
- (i.) which affects in any substantial way, the scope, quality, or performance of the project, or
- (ii.) Which would affect unfairly the competitive position of other suppliers presenting substantially responsive bids.
- 25. RMC reserves the right to reject any Bid, if:
 - (a) If the tender is incomplete; or
 - (b) At any time, a material misrepresentation is made or discovered; or
 - (c) The Supplier does not respond promptly and diligently to requests for information required for the evaluation of the Bid.
- 26. In case the Bid is found to be responsive, the Bid would be evaluated in accordance with the Qualification Criteria as set out in Tender Notice.
- 27. In case the Bid is found to be inadequate, RMC may request the Supplier for modifications to the Bid submitted. As part of the evaluation of the Bid, RMC may also request the Supplier to submit clarifications.
- 28. The Supplier offering the lowest quotation for the "SUPPLY, DELIVERY & INSTALLATION OF 10 MT. CAPACITY WEIGH BRIDGE WITH REQUIRED SOFTWARE AND COMPUTER ACCESSORIES AT MRF CENTER, GARBAGE TRANSFER STATION, RAIYADHAR AS PER TERMS AND SPECIFICATIONS." would be declared as the Preferred Supplier for the same. However RMC is not bound to accept the lowest or any tender which may receive against this tender.RMC may either choose to accept the Price bid of the Preferred Supplier or invite him for negotiations.
- 29. In case there are two or more Suppliers quoting the same price, RMC may in such case call all such Suppliers for negotiations and select the Preferred Supplier on the outcome of the negotiations. The selection in such cases shall be at the sole discretion of RMC.
- 30. In the event of acceptance of the Preferred Supplier with or without negotiations, RMC shall declare the Preferred Supplier as the Successful Supplier. RMC will notify the Successful Supplier through a Letter of Award (Preliminary work order) that its Bid has been accepted.

31. Notwithstanding anything contained in this tender, RMC reserves the right to accept or reject any quotation, or to annul the bidding process or reject all quotations, at any time without any liability or any obligation for such rejection or annulment, without assigning any reasons thereof.

32. PAYMENTS DUE FROM CONTRACTOR.

The Municipal Commissioner shall be entitled to recover costs, damages, or expenses for which under the contract, the contractor is liable to the RAJKOT Municipal Corporation from any money due or becoming due to the contractor under the contract or Municipal Commissioner will have the liberty to recover the amount from the contractor.

- 33. Any company/subsidiary/associate/parent or any of their having same promoter are not eligible to participate who has been blacklisted by any of Govt. Department or any ULB's (Urban Local Bodies in India). If it comes to the notice of the RMC authority at any point of time, during the tendering or execution stage of the work that the tenderer has been blacklisted by any Govt. organization (as mentioned above), then all the payments due to him shall be forfeited and firm will be blacklisted.
- 34. The bidder should provide accurate information on any litigation history or arbitration resulting from contracts completed or under execution by him over the last ten years. This should also include such cases, which are in process/progress. A consistent history of awards against the bidder of any partner of a joint venture may result in failure of the bid. In case the bidder has not provided such information and has come to the notice of the Authority, the tender will be rejected at whatsoever stage and in such case all the losses that will arise out of this issue will be recovered from the tenderer/contractor and he will not have any defense for the same.
- 35. The contractor shall not assign or sub-let his contract or any substantial part thereof to any other agency without writing permission of Municipal commissioner, RMC.
- 36. All articles supplied shall strictly conform to the specifications, trademark laid down in the tender form.
- 37. Any change in the constitution of the firm/association etc. shall be notified forth with by the contractor in writing to the Corporation and such change shall not relieve any former member of the firm, etc., from any liability under the contract.
- 38. The approved supplier shall be deemed to have carefully examined the total work; conditions, specifications, size, make and drawings, scope of work etc. of the goods to be supplied and Installed.
- 39. Warranty/Guarantee clause-
 - The tenderer would give guarantee that the Machines/Equipments would continue to confirm to the description and quality as specified for a period indicated in the table given below from the date of delivery of the Machines/Equipments to be purchased and that notwithstanding the fact that the Corporation may have expected and/or approved the said Machines /Equipments, if during the guarantee/warrantee period the said Machines/equipment be discovered not to confirm to the description and quality aforesaid or have determined (and the decision of the Municipal commissioner, RMC in that behalf will be final and conclusive) the corporation will be entitled to reject the Machines/Equipments or such portion thereof as may be discovered not to confirm to the seller's risk and all the provision relating to rejection of goods, etc. or such portion thereof as is rejection by the Corporation, otherwise the tenderer shall pay such damage

48. Forfeiture of Security money: -

Security amount in full or part may be forfeited in the following cases:-

- When any terms and conditions of the contract is breached
- When tenderer fails to make complete supply, installation, commissioning and testing of the equipments/machineries satisfactorily.
 The decision of the Municipal Commissioner, RMC in this regard shall be final.

49. Force Majeure

Now with standing the provisions of tender, the Supplier shall not be liable for forfeiture of its performance security, liquidated damages or termination for default, if and to the extent that, its delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure.

For purposes of this Clause, "Force Majeure" means an event beyond the control of the Supplier and not involving the Supplier's fault or negligence and not foreseeable. Such events may include, but are not limited to, acts of the Purchaser either in its sovereign or contractual capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.

If a Force Majeure situation arises, the Supplier shall promptly notify the Purchaser in writing of such conditions and the cause thereof. Unless otherwise directed by the Purchaser in writing, the Supplier shall continue to perform its obligations under the Contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.

- 2. The technical specification of weigh bridge and software details are mentioned in chapter-5. Successful bidder will have to supply and install weigh bridge and required software as per technical specification.
- 3. **Location of work:** Material recovery facility centre, garbage transfer station, Raiyadhar near water treatment plant, Rajkot.
- 4. **Scope of work** :There are two weigh bridges of 50 M.T. capacity with software facility at garbage transfer station, Raiyadhar for incoming and outgoing weighing of waste. Successful bidder will have to supply and install weigh bridge at above location and will have to provide software which links with those two weigh bridge software.
- 5. Necessary civil work for installation of weigh bridge will be executed by Rajkot Municipal Corporation. Successful bidder will have to submit required detail drawing.
