I. Financial Criteria :

1. Experience certificate from Govt., Semi Govt., Institutions, Theme parks & gardens at least one work of similar nature of Rs.5,00,000/- or two work of Rs.2,50,000/- is completed in last five yrs. **[this is a specialized work]**
2. An average Annual Turnover of Last five years should not be less than Rs.10.00 lacs.
3. Working capital must not be less then Rs. 3.75 lacs.
4. Bank Solvency should not be less than Rs. 1.00 lacs.
5. The supplier should have submitted receipt of professional tax in three month last financial year.
6. The lowest bidder will have to supply the samples of any two different topiary frames within seven (7) days after our instructions.

II. Experience Criteria :

The bidder should possess following minimum experience:

1. Bidder should have completed at least one work of similar nature of Rs...12,00,000.00/- amount or two works of Rs.8,00,000.00/.. completed in last 5 years of Government or Semi Government as a main contractor.
2. Joint Venture is not applicable.
3. The eligible contractor will have to be registered as per E.S.I. act and should produce the said registration certificate to the Garden Department of R.M.C.at the time of submission of required document.
4. The agency should have paid the professional tax of the previous year.
5. The agency should have should have submit (Appendix A to F)
